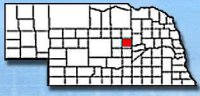

Foltz stated a current copy of the Open Meetings Act is posted on the south wall of the boardroom and copies are available for the public if requested. Everyone present joined in the Pledge of Allegiance.

The meeting was then turned over to the County Clerk. Mindy Grossart County Clerk acting as temporary Chairman asked for nominations for a 2021 County Board Chairman, Leslie moved to nominate Jordan Foltz as Chairman for 2021, a second was not received. Motion by Leslie to designate the Greeley Citizen as the Official County newspaper for 2021, second by Foltz. Roll Call Vote: Leslie yes, Foltz yes, Goldfish no. The Greeley County website (www.greeleycounty.ne.gov) is declared as an official means of publication. Motion was made by Leslie, second by Goldfish to approve the Board Appointments that Greeley County is associated with for 2021. Roll Call Vote: All yes, motion carried. Motion made by Leslie to approve the Courthouse Hours from 8:00 a.m. – 4:00 p.m., second by Goldfish. Roll Call Vote: All yes, motion carried.

Leslie moved to appoint Christopher Hayes as the County Surveyor, second by Goldfish. Roll Call Vote: All yes, motion carried. Motion made by Goldfish to appoint Janet Wood as the County School Supt, second by Leslie. Roll Call Vote: All yes, motion carried. Motion by Goldfish to appoint Lance Harter as Highway Superintendent, second by Leslie. Roll Call Vote: All yes, motion carried. Leslie moved to appoint Mark Bauer as the Emergency Manager, second by Goldfish. Roll Call Vote: All yes, motion carried. Motion made by Leslie to appoint Walter Bjorklund as Weed Superintendent, second by Goldfish. Roll Call Vote: All yes, motion carried. Motion by Leslie to appoint Franz Trumler as Planning & Zoning Administrator: in addition to his monthly salary Franz will receive \$25.00 phone reimbursement monthly, second by Foltz. Roll Call Vote: All yes, motion carried. Veteran Service Interlocal Agreement, Leslie moved to continue with the agreement, second by Goldfish. Roll Call Vote: All yes, motion carried.

The County Mileage reimbursement rate is set at 56¢ according to Section 81-1176 effective January 1, 2021 subject to change if the government adjusts the rate. The Sheriff's Department is entitled to charge an additional 3¢ if serving papers.

Any and all resources such as savings and checking accounts, cash on hand, insurance, and any funeral benefit through Social Security or other sources are to be applied against the county funeral allowance, second by Leslie. Roll Call Vote: All yes, motion carried. All contractors will file proof of liability insurance with the County Clerk prior to any work being done.

Cindy Bassett, County Attorney spoke briefly about road 503A and a need to possibly adopt a resolution. She requested additional time to review the situation before any action is taken.

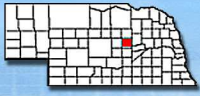

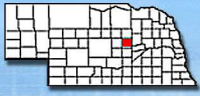

Great Plains Communications sent several techs to the meeting to answer any questions. After discussion, Leslie moved to approve the agreement with Great Plains Communications, second by Goldfish. Jessica Fenske, Assistant Diversion Specialist with Healing Hearts & Families met with the Board. They are currently working with Blaine, Custer, Dawson, Gosper, Greeley, Hooker, Logan, Loup, McPherson, Thomas and Valley Counties. She presented a Memorandum of Understanding for 2021 Community Based Juvenile Services Aid to the County Board. Goldfish moved to approve the Memorandum of Understanding, second by Leslie. Motion made by Goldfish to open the Livestock Friendly County designation public hearing at 9:45, second by Leslie. Roll Call Vote: All yes, motion carried. Franz Trumler, Planning & Zoning Administrator met with the Board to discuss the process of applying for a Livestock Friendly County designation for Greeley County. He stated the Livestock Friendly County designation was heard by the Planning & Zoning Committee on February 16th and passed with a 5-1 vote. Steve Martin, Executive Director AFAN was present by telephone to answer any questions. Steve stated they reviewed our Planning & Zoning Regulations and were concerned about the following: 1) Limit on the number of animal units at 20,000, 2) Odor footprint typo error, 3) Pit - Building feedlot odor footprint. Tom Kruml spoke in neutral and Kristy Barnes spoke in opposition during the public hearing. Motion made by Goldfish to close the public hearing at 10:40, second by Leslie. Roll Call Vote: All yes, motion carried. Foltz moved to approve Livestock Friendly County designation based on 1) 5-1 vote the Planning & Zoning Commission recommended, 2) keeping the same Planning & Zoning Regulations & 3) the County can vote the designation in or out anytime, second by Leslie.
