

Greeley County Commissioner Minutes

January 10, 2023

The Greeley County Board of Commissioners convened in open and public session at 9:30 a.m. on the 10th day of January 2023 in the Boardroom, Greeley County Courthouse. Notice of the meeting was given by publication in the Cedar Valley News.

Answering present at Roll Call were Jordan Foltz, Joe Leslie, and Dennis Wadsworth. Also present was County Attorney Cindy Bassett and County Clerk Mindy Grossart. Foltz stated a current copy of the Open Meetings Act is posted on the south wall of the boardroom and copies are available for the public if requested. Everyone present joined in the Pledge of Allegiance.

The meeting was then turned over to the County Clerk. Mindy Grossart, County Clerk acting as temporary Chairman asked for nominations for a 2023 County Board Chairman. Leslie moved to nominate Jordan Foltz as Chairman for 2023, second by Wadsworth. Roll Call Vote: All yes, motion carried. Jordan Foltz, Chairman asked for nominations for a Vice Chairman for 2023, Wadsworth nominated Joe Leslie for Vice Chairman, second by Foltz. Roll Call Vote: All yes, motion carried.

Motion by Leslie to designate Cedar Valley News as the Official County newspaper for 2023, second by Wadsworth. Roll Call Vote: All yes, motion carried. The Greeley County website (www.greeleycounty.ne.gov) is declared as an official means of publication. Leslie moved to set the county board meetings for the second and fourth Tuesday of every month at 9:30 a.m. unless otherwise advertised, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion was made by Wadsworth, second by Leslie to approve the Board Appointments that Greeley County is associated with for 2023. Roll Call Vote: All yes, motion carried. Wadsworth moved, second by Leslie to approve Resolution 23-1, appointing Dennis Wadsworth as the representative to Loup Central Landfill Association and Joe Leslie as alternate. Roll Call Vote: All yes, motion carried.

Josh Grummert, RLS was present to meet the Board and express interest in providing a proposal for the 2023-2026 Greeley County Surveyor Appointment. The Board previously received a letter of reference for Grummert Professional Services from County Highway Superintendent Lance Harter. The Board thanked Josh for attending the Board Meeting. Leslie moved to appoint Josh Grummert as the County Surveyor, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion made by Leslie to appoint Janet Wood as the County School Superintendent, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion by Leslie to appoint Lance Harter as Highway Superintendent, second by Wadsworth. Roll Call Vote: All yes, motion carried. Foltz moved to appoint Rod Johnson & Bill McManus as Co- Emergency Managers, second by Leslie. Roll Call Vote: All yes, motion carried. Motion by Wadsworth to appoint Carol Trumler as Planning & Zoning Administrator: in addition to her monthly salary Carol will receive \$25.00 phone reimbursement monthly, second by Leslie. Roll Call Vote: All yes, motion carried. Motion made by Leslie to appoint Margaret Valladao as Weed Superintendent, second by Wadsworth. Roll Call Vote: All yes, motion carried.

Mark Bauer submitted a letter of retirement from the position of Greeley County Emergency Manager. Motion made by Foltz to accept the letter of retirement with regret, second by Leslie. Roll Call Vote: All yes, motion carried. The Board expressed their appreciation for everything he has done for Greeley County, especially during the 2019 flood.

The County Mileage reimbursement rate is set at \$0.655 according to Section 81-1176 effective January 1, 2023, subject to change if the government adjusts the rate. The Sheriff's Department is entitled to charge an additional 3¢ if serving papers.

The following banks were reviewed as depositories for the year 2023: First National Bank, State Bank of Scotia, Citizen's State Bank, Homestead Bank, Henderson State Bank & NPAIT. Leslie moved to approve the 2023 depositories and to authorize the County Treasurer to invest idle funds appropriately second by Wadsworth. Roll Call Vote: All yes, motion carried.

A physician from the Howard County Medical Center will remain as the County Doctor. Motion made by Leslie to set the County burial policy as follows: the County will pay \$1,000.00 for cremation, second by Wadsworth. Roll Call Vote: All yes, motion carried. Any and all resources such as savings and checking accounts, cash on hand, insurance, and any funeral benefit through Social Security or other sources are to be applied against the county funeral allowance.

All contractors will file proof of liability insurance with the County Clerk prior to any work being done.

The County Officials rate salary was set in Resolution dated December 28, 2021. County Assessor Deputy, Clerk Deputy, Treasurer Deputy are set between 65%-75% and Sheriff Deputy 65%-85% of the official's salary. After a short discussion and review of comparable wages, motion by Wadsworth to approve 5% increases for all hourly employees and an additional one dollar increase for Road Shop Foremen, second by Leslie. Roll Call Vote: All yes, motion carried.

Wadsworth moved to approve the 2023 official holidays as set by State Statute 25-2221, second by Leslie. Roll Call Vote: All yes, motion carried. All days declared by law or proclamation of the President &/or Governor to be a holiday.

Motion was made by Leslie to waive the reading and approve the county board minutes from the December 28, 2022 meeting, second by Foltz. Roll Call Vote: Leslie yes, Foltz yes, Wadsworth abstain, motion carried.

Jon Howard gave a letter of resignation to the then Greeley County Sheriff Dave Weeks. The letter was given to the Clerk's Office on December 27, 2022. Leslie moved to accept the letter of resignation effective December 23, 2022 as requested, second by Wadsworth. Roll Call Vote: All yes, motion carried.

Lance Harter, Hwy Superintendent and Josh Gilbertson met with the Board to present a proposal for Fracture Critical Bridge Inspections, review plans and consider bidding materials for the Hill Road Structure Replacement (S-17 T-18 R-12), and discuss the 2022 Bridge Inspection Recommendations. Leslie moved to approve the proposal for FCB, second by Wadsworth. Roll Call Vote: All yes, motion carried. Motion made by Wadsworth to bid materials for the Hill Road Structure Replacement, second by Leslie. Roll Call Vote: All yes, motion carried. Bids will be opened on February 7th at 9:45 a.m. Lance also provided the Board with some updates in regards to sign inventory/retro-reflectivity, County Bridge Match Program, Bridge Inspection program updates and advice from NIRMA.

Motion made by Leslie, second by Wadsworth to adjourn BOE at 9:42 a.m. Roll Call Vote: All yes, motion carried.

An application for a Special Use Permit for Greeley Wind II, LLC was reviewed by the Board. Motion by Wadsworth to open the public hearing for Greeley Wind II, LLC at 9:45 a.m., second by Leslie. Roll Call Vote: All yes, motion carried. The purpose of the public hearing is to hear testimony in favor of, opposition to and to the Special Use Permit submitted by Greeley Wind II, LLC. Carol Trumler, Planning & Zoning Administrator gave an overview of the SUP and read the Finding of Facts and Conditions of Approval Set by the Planning & Zoning Commission. The Greeley County Planning & Zoning Commission unanimously approved the SUP with Bill Hamer abstaining from voting. FINDINGS OF FACT: 1. The contents of the Special Use Permit application were completed with required information. 2. The Applicant must satisfy all applicable Agency requirements before construction begins. 3. This Special Use Permit only permits wind energy development and does not permit any solar development. 4. The proposed Greeley Wind II, LLC (NextEra) meets the Greeley County and Zoning Regulations defined in Section 8.73 Commercial/Utility Grade Wind Energy System, and is consistent with the Greeley County Comprehensive Plan. 5. Testimony in favor of the application were: (Based on 30 years) approximately 27 million dollars in landowner payments would be given, approximately 19 million dollars for additional tax revenue will be given to Greeley County, including approximately 12.5 million dollars to the local school (Central Valley School District) and this project will create approximately five full-time jobs. 6. The approval of the Special Use Permit application was approved by the Greeley County Planning and Zoning members with Bill Hamer abstaining from voting because of personal conflict of financial interest in the project. 7. The approval of the Greeley Wind II LLC (NextEra) Commercial/Utility Grade Energy System Special Use Permit enforces the Greeley County Comprehensive Plan goal of providing opportunities for development in orderly, efficient, and environmentally sound manner allowing Commercial/Utility Grade Wind

Energy Systems in appropriate areas of the County. CONDITIONS OF APPROVAL: 1. Greeley Wind II, LLC (NextEra Energy Resources) shall enter into a written contract and agreement regarding the building up and maintenance of any county road used during any phase of the construction, maintenance and/or decommissioning of wind towers, turbines and any appurtenant structures built and or used by NextEra in this project before such roads are used in the construction, maintenance, and/or decommissioning process. 2. Representatives of NextEra shall report to the Greeley County Commissioners periodically to advise and inform the Board of Commissioners of the progress and status of this project until the project is completed. 3. Greeley Wind II, LLC (NextEra) shall secure an agreement to sell the project output within thirty-six (36) months of the date of the Commissioners approval of this Special Use Permit. If said agreement is not secured and a copy of said agreement remitted to the Commissioners before the above-described date, this Special Use Permit will become null and void. In the event Greeley Wind II, LLC (NextEra) does execute such agreement before the above-described date, Greeley Wind II LLC (NextEra) will be required to apply for a new Special Use Permit.

David Levy, Baird Holm, LLP and Matthew Jones, Next Energy Resources, LLC gave presentations on the project and answered questions. Matthew Jones pointed out some specifics and benefits of the Greeley Wind project: 1. Greeley Wind Nebraska, LLC is a wholly-owned, indirect subsidiary of Next Era Energy Resources, LLC. 2. Located in Greeley County, Nebraska. 3. Capital investment of approximately \$187 million. 4. Expected maximum capacity of up to 115 megawatts of clean, renewable energy produced by up to 41 turbines. 5. GE 2.82 MW up to 583' tall turbines, 374' Hub. 6. Building an operations and maintenance facility and substation. 7. Pending approval, expected to begin commercial operation by the end of 2024. 8. Providing approximately \$27 million in landowner payments. 9. Bringing approximately \$19 million in additional tax revenue for Greeley County. 10. Approximately \$12.5 million to Central Valley School District. 11. Generating approximately 250 temporary construction jobs. 12. Creating up to five full-time operations jobs. 13. Increasing local business activity. 14. To power more than 47,165 homes. Matthew stated some of the project studies include 2023-2024 Eagle and Raptor Nest Survey, Acoustic Bat Monitoring, Avian Use Survey, Breeding Bird Survey, Grouse Lek Survey, Prairie Orchid Survey, Wetland Delineation and Whooping Crane Stopover Habitat Assessment.

Testimony in favor of the Special Use Permit was given by: Nadine Bane, Russ Bloom, Mike Wood, Doug Wrede, Bob Dutcher, Brian Gydesen, Cilinda Meyer-Scheideler, Galen Barnes, Peggy Petersen, Ron Morearty, Joe Happ, Joel Glaser, Nick Dutcher, Galen Hansen, Bill Hamer, Darrel Cook and Butch Hughes. Some of those comments were: tax revenue, good company, reduce taxes, positives outweigh the negatives, help the county with roads, tax money for Central Valley Public School District, County, and Fire Department, good for local businesses, housing, and entire county, improve roads, tax relief and economic development. Neutral Testimony: Kristy Barnes and Nadine Bane. Some of those comments were: support of the project, concern for Bald Eagles and endangered species. Testimony in opposition to the Special Use Permit: Don Dugan, Bill Spelic, Robert Bernt, Cindy Glaser, Jerrald Scheef. Some of the opposition comments were: negative impact on game & parks, fish & wildlife, earthworms, bald eagles, whooping cranes, birds & bats, vibration, lights, sound, gag order, contract fine print, electricity from wind cannot be stored, size of the turbines, recycle issues, decommission concerns, explore other options, landscape, sandhills, decrease property value and beauty, greed, leave the land better for the next generation. Leslie moved to close the Public Hearing at 11:38 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. After discussion, Wadsworth moved to table the decision on the SUP until the March 28, 2023, County Board Meeting, second by Leslie. Roll Call Vote: All yes, motion carried.

The Commissioners recessed at 12:17 p.m. The Commissioners re-convened at 12:30 p.m.

Leslie moved to exit executive session at 1:00 p.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. Sheriff Paul Deaver was present for the discussion during the second executive session.

The Greeley County Board of Commissioners convened in open and public session at 9:30 a.m. on the 15th day of March 2023 in the Assembly Room, Greeley County Courthouse. Notice of the meeting was given by publication in the Cedar Valley News.

Answering present at Roll Call were Jordan Foltz, Joe Leslie, and Dennis Wadsworth. Also present was County Clerk Mindy Grossart. After discussion, there were some concerns in regard to access and if there is a need for an easement, the matter was tabled during the February 21st County Board Meeting. The survey now includes an ingress egress easement on the existing gravel drive through Blocks 12 and 13 at the request of the landowner. Motion made by Wadsworth to approve the Administrative Subdivision O'Connor Church of Visitation Permit :2023-2 HR#25-86, second by Leslie. Roll Call Vote: All yes, motion carried.

Leslie moved to enter executive session at 9:48 a.m. for the purpose of discussing possible litigation, second by Wadsworth. Roll Call Vote: All yes, motion carried. Leslie moved to exit executive session at 10:20 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. The County Board and Joe McNally were present for the executive session.

Sheriff Paul Deaver gave a brief update on the light bars for the law enforcement vehicles and advised the Board he is currently working on a policy and procedures manual and continuing to recover missing inventory.

Next, there was an informal question and answer period between the County Board of Commissioners and Next Era representatives, David Levy, Baird Holm Attorneys at Law along with Matthew Jones, Next Era Energy Resources. All three Board Members asked questions in regard to the insurance policies, Decommissioning Bond, Power Purchase Agreement, Road Use Agreement, required equipment, setbacks, tower/blade height, tower collapse, light flickering, shadow, noise, Greeley Wind II projected revenue, environmental studies, recycling, and EMT/Fire Department personnel training.

Matt stated they will try to select the best routes based on main roads in Greeley County. They will upgrade the roads to meet the required specifications and will return roads to County specs after the project has been built. Everything will be agreed upon in the County Road Use and Maintenance Agreement prior to the start of construction. Matt said they have recently had four projects in Nebraska, and they invest time and money into local communities, he referenced Steele Flats as one of the Nebraska projects. David explained the Power

Purchase Agreement has a general liability policy of a per occurrence limit of \$10,000,000 and Next Era Energy also has a property & casualty insurance policy on the equipment itself. David stated the Decommissioning Agreement is between the owner of the facility and the County, so it is not left to the landowner to decommission the project. Generally, during the tenth year of operation the owner posts a bond or a letter of credit with a third-party financial institution. David specified that State law also sets the bond to the tenth year of operation. He advised the Power Purchase Agreements are usually for 20 – 25 years. David clarified the landowner contracts have the setback of 1.5 times the height of the total system height which is more than Greeley County Planning & Zoning regulations require. He stated if the Board is concerned with the setbacks, it could be listed as a condition of the Special Use Permit.

Stoney asked the County Board to reject the application. Ken Ryan said Black Rock, Vanguard and State Street Corp are the top three investors in Next Era. He stated those three companies are also investors in of Ag Co Corp, John Deere, Ford Motor Company, McDonalds, Master Card, and Case New Holland. Duane Dilsaver expressed his concerns about the company not being here in ten years and recommended the bond be purchased during the first year.

Chairman Foltz, Vice Chairman Leslie, Commissioner Wadsworth, County Attorney Cindy Bassett & Joe McNally were present for the executive session.

Chairman Foltz explained they set the County Board agenda and the order of actions items. Going forward groups wishing to speak on non-agenda items will be given time during the public comments section of the County Commissioners Agenda. Foltz stated we welcome your comments, insights, and information if it is provided in an acceptable & appropriate way. The sheer number of phone calls we are receiving during the day, at night and on weekends is cumbersome and often involves matters we cannot discuss outside a Board Meeting. Often the public is seeking information about what an individual Board Member is doing or considering, and we simply cannot answer those questions. The appropriate place for those discussions is during a County Board Meeting. Chairman Foltz explained they conduct County Board Meetings and our daily lives and communication in a respectful, orderly fashion and expect everyone to do the same. If a meeting becomes unruly, we will immediately recess until the public comes to order. We will take threats of violence against any member of this Board, any Elected Officials, or any citizen seriously and will take whatever action is necessary to restore order.

The Special Use Permit for Greeley Wind II, LLC for a Utility- Scale Wind Energy Conversion System was discussed. The Special Use Permit was tabled during the February 21, 2023, Board Meeting. Motion made by Wadsworth to table the Special Use Permit vote for 120 days, second by Leslie. Wadsworth stated we have received multiple threats of litigation regarding the issue from all sides. It is our duty to make the best, the most informed and the legal decision regarding this issue. He explained we need time to receive appropriate legal counsel and allow that counsel time to properly advise us. Roll Call Vote: All yes, motion carried.

Bob Bernt representing Greeley County Alliance for WISE Energy spoke and presented information to the Board in regard to economics, wellbeing, safety, and health of Greeley County. A study on Agricultural losses due to Bat Fatalities, Autism and the effect of introducing a new noise source into quiet rural communities: risk factor from industrial wind power generation from Western University, Correspondence from Jan Hart, Kansas Senator Mike Thompson and Norman Stephens. Bob requested a moratorium on the wind turbine Special Use Permit until Planning & Zoning Regulations can be updated.

Next, the Board discussed a road study for potential road vacation/abandonment of a portion of 804th Rd east of 508th Wadsworth moved to approve Resolution 2023-1A, directing Lance Harter, Highway Superintendent to perform a road study on a portion of 804th Rd east of 508th, second by Leslie. Roll Call Vote: All yes, motion carried.

The Board discussed comparable wages in the surrounding area and determined Greeley County needs to increase the starting wage for road employees. After discussion, Leslie moved to increase the starting full time road wage to \$20.00 per hour and increase all road employees \$1.03 effective April 8th, second by Wadsworth. Roll Call Vote: All yes, motion carried.

Public Comment: Nadine Bane wanted to clarify during the Feb 21, 2023, meeting, she checked with the NE Games & Parks to see if Next Era Energy Resources had started new impact studies. At that time Nebraska Game and Parks did not have anything scheduled with Next Era. Matt Jones, Next Era Energy Resources stated they did meet with US Fish & Wildlife and Nebraska Game & Parks on March 6, 2023. Russ Bloom stated he is in favor of the project and appreciates the public comments. Bill Spelic expressed concerns with Planning & Zoning Regulations, application requirements and the decommissioning plan. Raymond Bernt recommended sending the application back and update the Planning & Regulations. Kristy Barnes brought up concerns about possible conflicts of interests, requested increased setbacks from schools and recommended updating Planning & Zoning Laws. Mike Wood expressed concerns about comments that were made at a meeting in Scotia, and he asked to have a show of hands of everyone present if they live in Greeley County. Cilinda Scheideler commented on the helicopters that were in the area. She stated they were doing bird studies looking for new nests. Butch Hughes commented on the Southwest Power Pool purchasing power and determining where the power goes. He recommended voting on the issue. Bob Bernt stated there was an issue in Otoe County where helicopters were used to scare off the birds & wildlife prior to the studies being performed. Andrew Hafer former employee of NPPD commented on the rolling blackouts that were experienced a few years back. He stated Nebraska had plenty of power compared to usage during that time. The nuclear, coal and natural gas plants were running and maintaining. He explained the Southwest Power Pool was begging for power to be sent to surrounding states that rely heavily on wind energy. Don Dugan commented on stockholders of Next Era Energy. He also questioned if the wind does not blow, will they bring in diesel generators to fulfill their contracts. Cindy Glaser shared some figures Boone County received from a large Wind Project: 19-20 \$120,000, 20-21 \$147,000 and 21-22 \$104,000. She is concerned how the County could budget if the amounts are always changing. Charlotte Jarman expressed concerns about the wind project and land use if the landowner changes their mind six months into the project. She does not want the decision made lightly.

Motion by Leslie to enter a second executive session for the purpose of discussing possible litigation at 11:00 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. Leslie moved to exit executive session at 11:26 a.m., second by Wadsworth. Roll Call Vote: All yes, motion carried. Chairman Foltz, Vice Chairman Leslie, Commissioner Wadsworth, County Attorney Cindy Basset & Joe McNally were present for the executive session.

She explained that Blue Stem and Next Era have followed all the Planning & Zoning rules of Greeley County and does not agree that a few people that are opposed to the wind farm want to change the rules now. Peggy stated the name plate tax comes back to the county along with additional taxes from Next Era building structures. Peggy presented information from the Nebraska Department of Revenue in regard to the Name Plate Tax. She also stated expansions have been allowed in Custer, Antelope, and Boone Counties. Sharolyn Morearty said she is a landowner and support of the wind project. She explained the project has been going on for 15 years with a lot of progress since Next Era has purchased it. She feels it will impact Greeley County in more positive ways than not. Penny Beran specified that she is speaking on behalf of her parents Nick & Bev Dutcher. She stated that she does not live in Greeley County but has spoken to a landowner from Boone County. She explained that his cattle have not been affected and that they are not scooping up loads of dead birds. Penny stated the landowner she spoke to does not have a vested interest in the project and he felt everyone benefited from the increased revenue and improvements for the County. Cilinda Meyer-Scheideler thanked the Board for their time and consideration for the wind project. She shared that Iowa has over 3,400 wind turbines across 33 counties and they are one of the largest ag producers. She also shared that she has been an EMT for over 35 years and safety is a top priority for her. Mike Wood presented some information from Antelope and Custer County on the

Name Plate Capacity Taxes. He explained in Custer County they pay 5,600 per mega watt in taxes so that would be \$640,000 in tax money and \$575,000 for landowner payments. He felt it would really improve the economy. Bill Spelic thanked Chairman Foltz for attending the Planning & Zoning meeting in Dawson County. He felt Greeley County is way behind in Planning & Zoning Regulations. He wants the Board to look at all the details and thanked them for waiting 120 days. He stated there are a lot of concerns coming out of Otoe, Jefferson, Lincoln, Dawson, Antelope, and Dixon Counties. A motion was made by Leslie to waive the reading and approve the county board minutes from the April 11, 2023, meeting, seconded by Wadsworth. Roll Call Vote: All yes, motion carried.

County payroll and vendor claims were reviewed by the board. Motion made by Leslie to approve payroll and claims, second by Wadsworth. Roll Call Vote: All yes, motion carried. GENERAL FUND: Salaries, 28,576.43, EFTPS Matching SS, 2,186.09, Ameritas Life Ins. Corp, Matching County Retirement, 1,874.96, Blue Cross Blue Shield, 11,508.53, ROAD FUND: Salaries, 10,211.85, EFTPS Matching SS., 781.22, Ameritas Life Ins. Margaret Valladao, Weed Superintendent presented Year End Weed Reports for the County Board to review. Three open files were closed, and 19 files remain open and need follow-up, office evaluation, county reports, and continuing education requirements were met. Leslie moved to approve Year End Weed Reports, second by Wadsworth. Roll Call Vote: All yes, motion carried. Margaret also requested approval to apply for grant opportunities for a side-by-side, trailer, sprayer, and spray. She is also applying for a grant to have aerial spraying on the Cedar River and the Loup River. Margaret explained if the grants are awarded to Greeley County, she will advertise in the legal newspaper for four weeks before any spraying is done. The Board also requested that she send letters to the landowners before any spraying is started. She agreed to advertise and send letters to the landowners but also advised if the landowner opts out of the grant opportunity, they are responsible for controlling the invasive species. Motion made by Leslie to allow the Weed Superintendent to apply for the side-by-side grant, sprayer, trailer, and spray, second by Wadsworth. Roll Call Vote: All yes, motion carried.

Heidi Borg, Agriculture Liaison with Congressman Adrian Smith's office met with the County Board to provide an update. She also hosted a mobile office in the Courthouse after she visited with the County Board. Heidi was available to meet with residents about federal issues, receive assistance from a federal agency, or discuss the services available through the Grand Island District Office.

Bryan Hill, Lake Mac Assessment presented a bid for a reappraisal of 1,808 parcels for Greeley County. He anticipates the cost would be \$229,239 or \$126.79 per parcel reviewed. The scope of service would include preliminary statistics, lot study, exterior inspection with new photos including vacant lots, verify measurement of all buildings, interior inspection if necessary, update costing to the latest available in the CAMA system, remove user defined codes and replace with Marshall & Swift codes, enter all data into the CAMA system, make sure all data is linked to sketches and site plan, build GIS map of neighborhoods, build depreciation tables according to your market, complete the cost approach to value, apply new values and verify new values in CAMA system, all values will be driven from appraisal model in the CAMA system, complete final statistics, a sales book and narrative report will be created for the office with all pertinent information from the reappraisal,

all pickup work will be done and growth figured for all parcels, he will attend CBOE protest hearings of residential properties up to three days each year, all of this process will comply with all Nebraska revised statutes and regulations set by Property Assessment Division. Gerri Behnk, Assessor stated Bryan has reviewed four townships in Greeley County and recommended having him complete the rest of the County for equalization across the County. She explained their office has learned a lot from Bryan and they have a good working relationship with Lake Mac Assessment. After discussion on bidding requirements, a motion was made by Leslie to table voting on the bid from Lake Mac Property Assessment until the next Board meeting, seconded by Wadsworth. Roll Call Vote: All yes, motion carried.

Leslie moved to enter the executive session at 10:12 a.m. to discuss possible litigation, second by Wadsworth. Roll Call Vote: All yes, motion carried. Wadsworth moved to exit the executive session at 10:56 a.m., second by Leslie. Roll Call Vote: All yes, motion carried. Chairman Foltz, Vice Chairman Leslie, Commissioner Wadsworth, County Attorney Cindy Basset & Joe McNally, McNally Law Office, and Carol Trumler, Planning & Zoning Administrator were present for the executive session.

Eddie Bomar, Nebraska Machinery submitted a purchase order and sales agreement for a 2018 Caterpillar 938M Loader \$215,000 and a GA905 Wheel Loader Grapple Bucket \$11,352. Both items were bid under the Sourcewell contract #032119-CAT. Motion made by Leslie to approve the purchase of the 938M CAT Loader and Grapple Bucket, second by Foltz. Roll Call Vote: All yes, motion carried. The 938M CAT Loader will replace the 950B Loader at the Scotia Roads site.

Sheriff Paul Deaver met with the Board to provide some updates. Paul needs to replace two laptops and printers for the law enforcement vehicles. He explained the software is not compatible with the old equipment. The items will be added to the next board meeting. The Board expressed appreciation to the Sheriff for his assistance with signs and road issues.

Next, the Board discussed the Special Use Permit for Greeley Wind II, LLC (NextEra Energy Resources). Chairman Foltz stated we take our duties as Commissioners for this county very seriously. We work very hard to make the best decisions we possibly can and make diligent efforts to educate ourselves on all sides of an issue. We reach out to other counties to determine what their best practices are and to consult with others who can give us prudent advice. We are committed to listening to the concerns of any person who comes to us and have spent countless hours listening and answering questions from anyone who contacts us and will continue to do that. We hear and consider opponents and proponents of wind energy and represent each one of you. We are taking every step necessary to ensure this decision is properly made. He explained that the Commissioners are only one step in the process. We, under our statutory authority, instituted a Planning & Zoning Commission and appoint its members, in consultation with the Planning and Zoning Administrator. That Commission, in consultation with planning specialists, constructed the Planning and Zoning Regulations and Comprehensive Plan. Every meeting of the Planning and Zoning Commission is an open meeting, and legal notice is published for every meeting, just like our commissioners' meetings. Chairman Foltz mentioned there are other lawyers, planners, and consultants involved in the making of the Planning and Zoning Regulations, there is oversight at each and every step of every process. The Chairman noted within our 120-day timeframe for making our decision on this permit, we find that, within that timeframe, a preliminary action is in order. In dealing with this issue of whether to grant the Nextera permit, we believe it is in the best interests of all sides to return the Nextera application to the Greeley County Planning and Zoning Commission for further consideration. We direct the Commission to hold a public hearing on the Nextera permit within 30 days of today's date. In that public hearing, we want the Commission to address the following, including, but not limited to *Clarify the height of the proposed wind towers. Currently, there is a difference between the height of the wind towers as stated in NextEra's December 29, 2022, letter to the Commission Administrator, and the height currently proposed by Nextera. *The precise location (within an arcsecond (101.27 feet)) of each wind tower, and an explanation from Nextera as to why a deviation in the placement of a tower would be necessary. *An update and documentation of all necessary studies and their completion or expected completion, and of all necessary licenses and permits from all applicable regulatory or oversight agencies. This public hearing, as well as any

other public hearings, or meetings held by the Commission in reference to this Nextera permit, is to be audio recorded. In the event the Commission finds it necessary to table its recommendation, it may only table its recommendation for a 30-day period. This is in order to keep our commitment to the Commissioners reaching a decision on this permit within the previously stated 120-day or less timeframe. Commissioner Wadsworth moved to neither allow nor deny the Nextera permit and that this board sends the Nextera permit back to the Planning and Zoning Commission for action and recommendation from that Commissioner as detailed by Chairman Foltz, seconded by Leslie. Roll Call Vote: All yes, motion carried.

County Attorney Cindy Bassett presented a Resolution for the Board to review regarding an alternative energy moratorium. Chairman Foltz read aloud Resolution 2023-3, Be it resolved, by the Greeley County Board of Commissioners, that a one (1) year moratorium on accepting any alternative renewable energy resource development applications or permits, submitted after the signing of this Resolution, is hereby invoked, and approved. Be it further resolved that the Greeley County Board of Commissioners hereby directs Greeley County Planning & Zoning Commission to review its county zoning regulations, to conduct any hearings, if necessary, and to make specific recommendations for changes to the county zoning regulations dealing with alternative renewable energy resource development and that such recommendations shall be made within eight (8) months of the date of this resolution. Be it further resolved that this moratorium may, at the sole discretion of the Greeley County Board of Commissioners, be extended, if necessary, to allow the Planning and Zoning Commission to continue its work as necessary regarding the goals previously described. Be it further resolved, that the said one (1) year moratorium shall become effective as of the date of the approval of this Resolution. Bob Bernt requested to be recognized to discuss a point of order. Joe McNally, McNally Law Office stated it will be allowed during the public comment portion of the meeting. A motion was made by Wadsworth to approve Resolution 2023-3, seconded by Leslie. Roll Call Vote: All yes, motion carried.

Public Comment: Valerie Conger spoke and read aloud a couple of paragraphs from the book titled Paradise Destroyed by Gregg Huber, she also stated she would like to be on the Planning & Zoning Commission. Cilinda Meyer- Scheideler stated they were contacted fifteen years ago about signing with the wind farm and she explained it was not a decision taken lightly. Cilinda stated they went out and researched other wind farms and spoke with bankers, landowners, and residents before deciding. She asked the Board to approve the wind farm. Kristy Barnes stated over the fifteen years we have learned more negative about wind farms. She is concerned about the environment, wildlife, and bird migration. He explained that wind energy is inefficient, the turbines are not being recycled they are being buried and the taxpayers are the ones paying for the subsidies. Butch Hughes would like to see a list of advantages of the wind farm, he can only see the disadvantages. He stated the 21 landowners are the only ones that are going to benefit. Butch explained Greeley County will not get to use any of the energy it will all be going to the southwest power pool. He stated it's a bridge to nowhere, and expressed concerns about the expense, decommissioning and liability. Kristy Barnes is concerned about the young people in the county. She had family up over the weekend and they were discussing children with autism and their sensitivity to sounds. Kristy thinks there needs to be a three-mile setback from schools.

Matt stated they have been investing in Nebraska since 2013 by owning and operating four wind energy centers: Cottonwood Wind in Webster County, Little Blue Wind in Franklin and Webster Counties, Sholes Wind in Stanton and Wayne Counties and Steele Flats in Gage & Jefferson Counties. He provided a Greeley Wind project timeline showing NextEra Energy Resources acquired development rights from Bluestem Energy Solutions in July 2022 and began the Special Use Permit application submittal in December 2022 with a targeted construction and commercial operation in 2025. He also provided some specifics regarding Greeley Wind Nebraska, LLC, is a wholly owned, indirect subsidiary of NextEra Energy Resources, LLC located in Greeley County. Capital investment of approximately \$208 million, expected maximum capacity of up to 115 megawatts of clean, renewable energy produced by 41 primary turbines with 3 alternate sites. Matt listed some project benefits over thirty years: providing approximately \$27 million in landowner payments, bringing approximately \$19 million in additional tax revenue for Greeley County, approximately \$12.5 million to Central Valley Public School District, generating approximately 250 temporary construction jobs, creating up to five full time operations jobs and increasing local business activity.

Bob Bernt, representing Greeley County Alliance for Wise Energy addressed the Board of Commissioners with concerns regarding the Special Use Permit for Greeley Wind II, LLC.

Next, the Board of Commissioners reviewed the application for a Special Use Permit submitted by Greeley Wind II, LLC (Nextera Energy Resources). After discussion, motion made by Foltz to approve the Conditional Use Permit of Nextera Energy to construct and operate a Commercial Wind Farm subject to the following conditions: Finding of Facts: Greeley Wind Nebraska, LLC ("Applicant") submitted an application (the "Application") for a special use permit to install and operate a utility-scale wind-energy conversion system (the "Project").¹ Located southwest of the Village of Greeley, Project infrastructure would occupy less than one percent of the Project's approximately 6,739 total acres. The Project would have a nameplate capacity of 115 megawatts and would interconnect to the Nebraska Public Power District's transmission system. The Greeley County Planning Commission (the "Planning Commission") and Board of Commissioners (the "County Board") previously permitted essentially the same project in 2016 and 2019, but those permits expired.

Section 6.2 of the Greeley County Zoning Regulations (the "Regulations") sets out the standards that guide the Planning Commission and County Board in approving applications for special use permits generally. Section 8.73 details additional standards for Commercial/Utility Grade Wind Energy Systems like the Project.

The Board of Commissioners hereby finds, based on substantial evidence in the record before it, including the Application, supplements, exhibits and testimony of Applicant and its representatives, that the Project, subject to the conditions of approval herein, meets all applicable requirements as follows:

1. The Application satisfies all applicable requirements of the Greeley County Zoning Regulations.

Applicant submitted the Application, and the County provided public notice of this meeting, in accordance with Section 6.2 of the Regulations. Additionally, the Application contains all of the information that Section 8.73 requires, including the permit and application fees under the Regulations. The Project, as proposed, complies with the special safety and design standards under Section 8.73.

In particular, the Greeley County Zoning Regulations require a minimum setback from an occupied residence of 1,000 feet. The minimum proposed setback is 1,873 feet. Similarly, the Greeley County Zoning Regulations require a maximum sound level at an occupied residence of 50 dBA. The maximum modeled sound level at an occupied residence for the project is 48 dBA.

2. The Project would not require rezoning of the property, is compatible with and similar to the use permitted in the zoning district and would not change the character of the zoning district.

The Project is in the AG-1 agricultural zoning district. In that district, Sections 5.15(22) and 8.73 of the Regulations permit wind facilities as a special use. Wind facilities like the Project are compatible with agricultural activities and will not change the character of the AG-1 zoning district.

3. The Project would not harm adjacent property or depreciate the value of the surrounding structures or property.

No evidence was presented to support the claim that wind facilities cause a decline in surrounding property values in any nearby region. There is evidence that commercial wind facilities bring multiple economic benefits to the surrounding area, including property tax revenue, low-cost energy and new jobs.

The Project represents an investment of approximately \$200,000,000 in Greeley County and will support the local economy through the purchase of local and regional goods and services and hiring of local workers. The Project will provide up to 200 construction jobs and six to eight full-time operation and maintenance jobs. Additionally, the Project will generate more than \$575,000 in annual property-tax revenue over its estimated useful life. Central Valley Public School Districts will receive more than \$390,000 annually, and Greeley County itself will receive more than \$110,000. Other local taxing authorities will also benefit. Overall, the Project will economically benefit Greeley County.

4. The Project complies with the Greeley County Comprehensive Plan (the “Comprehensive Plan”).

Under the Comprehensive Plan, Greeley County intends to “... promote the implementation of alternative energy sources such as [w]ind ... to reduce the reliance on traditional fuel and energy sources.” The Comprehensive Plan also states it is Greeley County’s goal to provide opportunities for developing in an orderly, efficient and environmentally sound manner. The Project furthers these goals and is consistent with the Comprehensive Plan.

5. The Project would support the public health, safety and welfare.

The Application demonstrates the Project will support the public health, safety and welfare of Greeley County and its residents and property owners. Among the factual bases for this finding are that:

*The Project will domestically generate clean, renewable energy. Proponents testified this would comply with the Comprehensive Plan. *The Project will provide additional income to landowners. Proponents testified the Project would pay approximately \$27,000,000 in lease payments to participating landowners over the Project’s estimated 30-year life. *The Project will create a combination of temporary and full-time jobs in Greeley County. Proponents testified this would result in economic benefits to many sectors of the local economy. *The Project will result in additional property tax revenue to Greeley County, Central Valley Public School District and other taxing jurisdictions. Proponents testified these taxes would greatly benefit Greeley County and its public schools. *The setbacks and other requirements in the Regulations, along with the below conditions of approval, ensure the Project would protect and nurture the public health, safety and welfare of Greeley County and its residents and property owners. *Applicant and its predecessors, in coordination with federal and state agencies, have produced numerous and voluminous professional reports and studies confirming the Project would not harm wildlife in or around the Project area and identifying measures Applicant would take to further mitigate any such impacts. *Wind energy and farming are entirely compatible such that the Project would not impair, and by constructing new access roads and diversifying income sources, would enhance the agricultural economy of Greeley County. *The Project will increase local sources of energy production, and due to necessary transmission grid enhancements and the injection of power locally on the grid, would enhance the reliability of the electric grid in Greeley County. *The Project will purchase “back feed” power from the local distribution utility, thereby providing them with a stable, long-term load. *Construction and long-term employees will reside and spend money in Greeley County, which will result in increased property tax and sales tax revenues to Greeley County and the State of Nebraska. *Subject to Federal Aviation Administration (the “FAA”) and Federal Communications Commission (the “FCC”) approval, Applicant will implement an Aircraft Detection Lighting System (“ADLS”) to reduce the duration of time red aircraft-warning lights. This will significantly mitigate the impact of such lighting to surrounding residents.

The Project shall comply with the following conditions of approval. Applicant shall provide written evidence of such compliance to the Zoning Administrator prior to commencing construction of the Project and may only commence construction once the Zoning Administrator has confirmed compliance with the following conditions of approval. Applicant shall maintain compliance with these conditions as long as the Project is operational. Applicant acknowledges that the project area consists of approximately 6,739 acres and does not include land area added through any subsequent action by Applicant, any non-participating landowner solicitations or any other solicitations or actions on the part of Applicant.

1. Wind turbine generators in the Project shall be no taller than 501 feet above ground level to the tip of the blade at the 12 o'clock position. 2. The Project shall include no more than 41 wind turbine generators. 3. Applicant shall only install wind turbine generators in the locations represented in the final readout sheet of tower sites, which are set out in arcseconds of longitude and latitude. If Applicant must move a tower site from the readout sheet site, that move must be reviewed and approved by the County Board, and then only for good cause shown, such as a rock formation precluding such original placement. 4. The Project shall comply with all special safety and design standards under Section 8.73 of the Regulations, including all setback, clearance, structural, aesthetic, sound, lighting, electromagnetic interference, signage, drainage and waste-disposal requirements. 5. Wind turbine generators shall be setback from the base of each turbine by at least a diameter plus the applicable building setback from any nonparticipant's property line. 6. Applicant shall provide and obtain approval by the County Board of a decommissioning plan and agreement (as approved by the County Attorney), including future posting of decommissioning security. 7. Before start of construction, including placement of materials and road construction and upgrades, Applicant shall post a \$12 million dollar cash escrow for the benefit of Greeley County. The funds will be held in a holding fund, to cover the costs of decommissioning the project. 8. A portion of the interest accrued on each account, see below, will be used for a betterment fund for Greeley County, and distributed equitably and in the sole discretion of County Board on a yearly basis. The specific program requirements for distribution will be determined by County Board. 9. Every five years after commercial operation, Applicant shall provide the County an updated decommissioning cost estimate prepared by a qualified third party. 10. The County will release the decommissioning security escrow once the project company decommissions the facility pursuant to the decommissioning agreement's requirements. 11. Before construction begins, Applicant shall identify any county, municipal or township road the Project wishes to utilize, conduct a pre-construction survey of said roads, obtain approval by the County Board of a road use and maintenance agreement and remain responsible for restoring said roads and bridges to preconstruction conditions through the end of the decommissioning process. 12. In the event Applicant is found to be using any road other than those approved in 11., above, Applicant shall pay a fine of \$5,000.00, plus damages to that road. Such fine will be paid within 30 days of the finding that Applicant used an unapproved road. In addition to a fine and payment of damages, any subsequent occurrence of such violation may result in County Board suspending or revoking the permit of Applicant. 13. Applicant shall supply to County Board, and subsequently comply with the Road Use Agreement (as approved by the County Attorney) during construction and operation, including fines for noncompliance, to be determined within 30 days of August 8, 2023. Applicant shall work with County Engineer and County Board to determine haul route(s) for construction and maintenance. Applicant shall notify County of intent to do any post construction work other than regular maintenance. 14. Applicant shall post a \$5 million dollar cash escrow for the use of Greeley County in the event of any and all damages done to, or catastrophic destruction or damage to, any approved Road in the project, from the time of construction through the end of decommissioning the project. 15. Greeley County shall be the recipient of any and all interest accrued on the Road Use account. A portion of the interest accrued will be placed into the escrow account to index the account for inflation. 16. County Board shall give Applicant immediate notice of any road damage that must be repaired. In the event Applicant fails to repair such damage immediately, in its sole discretion, County will draw funds from the Road Use account to pay for such repairs. In the event a catastrophic event or emergency prevents Applicant from immediately responding, County shall have the right to immediately repair all such damage. 17. Any funds from the Road Use account County Board spends shall be invoiced to Applicant, who will reimburse County to the extent of the spent funds, within 30 days of receiving a detailed invoice or notice of such expenditures. In the event Applicant fails to reimburse the above-described funds, County Board reserves the right to suspend or revoke the permit of Applicant. 18.

Greeley County shall be the recipient of any and all interest accrued on the Decommissioning account, see 7., above. A portion of the interest accrued will be placed into the escrow account to index the account for inflation. 19. A portion of the interest accrued will be used for a betterment fund for Greeley County and distributed equitably and in the sole discretion of County Board on a yearly basis. The specific program requirements for distribution will be determined by County Board. 20. County Board will release the Road Use escrow account once the project company restores the permitted use roads to the satisfaction of County Board, pursuant to the Road Use agreement's requirements. 21. Applicant shall provide the County Board Chairman and County Clerk with, and maintain current, local contact information for a person with the ability and authority to resolve day to day operational issues that may arise with the Project. 22. Applicant shall provide the County Board Chairman and County Clerk with, and maintain current, local contact information for a Construction Manager, who has the ability and authority to resolve any and all construction issues that may arise with the Project. 23. During the entire construction of the project, Applicant shall provide a report at every County Board meeting regarding information and updates of that construction. 24. Applicant shall provide a quarterly report to the County Board regarding compliance with these conditions of approval. 25. Applicant shall secure an agreement to sell the Project's output within 36 months of the date on which the County Board approves the Application. 26. Applicant shall install an Aircraft Detection Lighting System if the Federal Aviation Administration and Federal Communications Commission approve of the use of such a system at the Project site. Applicant shall use good faith best efforts to obtain such approvals. 27. Applicant shall enter into an Indemnification Agreement, as approved by the County Attorney, and defend Greeley County at no cost to Greeley County in the event of litigation brought by a third-party regarding approval of the Application, or any subsequent issues related to the operation of the project. 28. Applicant shall not have sole final settlement authority on behalf of the county, either monetarily or through injunctive relief, arising out of the application process or subsequent approval of the special use permit. 29. Within two hours of an aerial sprayer who is planning to spray one or more fields in the Project area requesting assistance, or at a later time otherwise requested or agreed upon, Applicant shall operate the Project in the manner the sprayer reasonably requests during the spraying timeframe to facilitate the sprayer's convenience and safety. Applicant shall provide and publish a means to receive such notice. 30. Applicant's failure to comply with this condition shall subject it to a fine of up to \$1,000 per occurrence, and provided that Applicant shall have an opportunity to show cause to the County Board of Commissioners as to any alleged violations or fines. Upon a third violation of this clause, County Board reserves the right to suspend or revoke the permit of the Applicant. 31. Applicant shall timely provide Greeley County copies of any future environmental studies as completed and approved by authority having jurisdiction, e.g., U.S. Fish and Wildlife Service. 32. Applicant shall hold all wind turbines in this project in an operational state at all time during the life of the project. In the event a turbine is damaged or rendered unusable, Applicant shall immediately inform County Board of the situation, provide a plan for correcting the problem, and at Applicant's expense, and using no funds from the decommissioning holding fund, shall timely either repair or decommission that turbine. 33. Applicant shall not dispose of turbine blades in Greeley County, and the blades must be removed from Greeley County as a whole blade. All other components of any wind turbine must be removed from Greeley County in the same form as it came into the County. Applicant agrees that no part of this project qualifies Applicant for the decommissioning process to be a salvage or junk yard, and that its permit does not include any provisions of Greeley County Planning and Zoning Article 6.3. 34. Applicant shall provide snow removal as necessary for the Project roads during construction and shall do so in a timely manner in order to maintain clear roads for local traffic at all times. 35. Applicant shall offer a participation agreement on reasonable terms to any person owning property within one mile of the project boundary. For purposes of this condition, the project boundary shall be the acres originally set forth in the Application. 36. Applicant shall obtain and provide a 911 address for each turbine, the Project substation, and the operation and maintenance building, and shall provide that list to the County Board before construction begins. 37. Applicant shall not seek to use eminent domain to acquire any property right for the Project, from granting of the permit, through the end of decommissioning. 38. At all times from commencement of construction to completion of decommissioning, Applicant shall be liable for any injury or property damage the Project causes, as limited by applicable law regarding torts, causation, proportional liability and damages, and will hold County harmless from same. 39. Applicant acknowledges and agrees to County Board that Applicant's personnel will respond to and handle any emergency situations involving property or persons in or

on a wind turbine generator. Applicant acknowledges and agrees that it is liable accordingly for any injury or property damage that may occur in such a situation and that Greeley County, its fire and safety personnel, its law enforcement, and any other mutual aid agencies, have no liability or responsibility to attempt to rescue an injured or distressed person or attempt to prevent property damage in or on a wind turbine, and hold the above described parties harmless from same. 40. At all times from commencement of construction to completion of decommissioning, Applicant shall maintain insurance on the Project with property and casualty limits of not less than: \$1,000,000 per occurrence for Employer's Liability, \$2,000,000 per occurrence and \$4,000,000 aggregate for Commercial General Liability, \$1,000,000 per occurrence for Business Auto Liability (combined injury and property damage), \$5,000,000 per occurrence and aggregate for Excess Liability, Full Replacement Cost for All Risk Builder's Risk during construction until commercial operation, and Full Replacement cost for All Risk Property during operation through decommissioning. Applicant shall provide proof of such insurance to the Greeley County Zoning Administrator prior to commencing construction and at any time upon reasonable request. 41. Applicant and County Board agree that it is the express intent of both parties that these conditions be incorporated into the various Agreements and Contracts to be signed by the parties. In the event any condition is inadvertently omitted from these Agreements and Contracts, these conditions remain in full force and effect. A copy of this document, duly executed by the County Board, shall be made part of the agreement between County Board and Applicant, and this copy will be signed by County Board and the appropriate representatives of Applicant. 42. Applicant agrees that any deviation from any term, condition, agreement, or contractual obligation entered into with County Board, will subject Applicant to suspension or revocation of this permit. County Attorney, Cindy Bassett clarified some of the conditions, the motion was seconded by Wadsworth. Roll Call Vote: Foltz yes, Wadsworth yes, Leslie yes, but stated he did not agree with conditions 7 & 14. Motion carried.

Next, the Board reviewed an agreement from the State of Nebraska. The State of Nebraska Statutes require an annual Certification of Program Compliance to the Nebraska Board of Public Roads Classifications and Standards to be filed on or before October 31 each year.
